

## **DIALICIOUS CONTENT REMOVAL POLICY**

Dialicious attaches particular importance to the freedom of expression of its Members.

This is, in particular, why the service has not implemented prior moderation.

After all, the service is certainly a space dedicated to sharing the passion for these objects that we wear on our wrists but is also intended to spark debate.

Dialicious, however, reminds us, in these Terms and Conditions, of moderation and cordiality.

Despite these precautions, if you notice that content infringes your rights in any way, you can request its removal from the address [request@dialicious.com](mailto:request@dialicious.com) by following the procedure below.

You are invited to first consult the Privacy Policy and, more particularly, the section relating to “conservation of personal data of persons requesting the withdrawal of a Review”.

You are asked to keep in mind that Dialicious has no other ambition than sharing a passion and that it will make a point of processing withdrawal requests sent to it as quickly as possible. It does not have sufficient tools or staff to respond immediately.

### **Do you consider that content infringes your intellectual property rights?**

#### **1. Process**

Please tell us:

The exact URL address of the content;

Your last name, first name and, where applicable, the name of your company or legal entity in whose name you are requesting withdrawal. In the latter case, you must produce a mandate to certify that you have standing to act;

The reasons why you consider that the content in question infringes your intellectual property rights;

An explanation of why the content is protected and proof of the ownership of your rights or of the legal entity for which you are acting.

When your request is based on a court decision, which establishes the alleged illegality, you simply indicate:

The exact URL address of the content;

Your last name, first name and, where applicable, the name of your company or legal entity in whose name you are requesting withdrawal. In the latter case, you must produce a mandate to certify that you have standing to act;

#### **2. Reminders**

Reviews published by Members are only open to natural persons and any Review with a commercial aim is prohibited by the Terms and Conditions.

Consequently, we thank you, in the event of a request relating to trademark law, for explaining to us how the Review meets conditions of use in the conduct of business.

Any request that does not scrupulously meet the conditions set out above will not be processed.

The fact that the request meets the above conditions does not imply automatic withdrawal. We may refer your request to our legal teams.

In any case, you will be informed either of the withdrawal or of the reasons why we have not done so.

Finally, as specified in its Terms and Conditions, Dialicious prohibits the publication by its Members of any Review likely to infringe intellectual property rights. It cannot, therefore, be considered as a content sharing service provider within the meaning of Article 2.6 of Directive (EU) 2019/790.

### **Do you consider that content is defamatory, offensive or denigrating?**

#### **1. Process**

The laws on freedom of expression are such that we have no other choice than to ask you to produce a court decision ruling unambiguously on the comments you are denouncing and in relation to you or the person you are denouncing. represent. You must also provide us with:

- Proof of your identity;
- If applicable, a power of attorney allowing you to represent a legal entity;
- The exact URL address of the content.

#### **2. Details**

In the event of notorious insult, you can directly report the content to the address [request@dialicious.com](mailto:request@dialicious.com).

We will contact the author and ask them to remove the insult. If the author does not comply with this order, we will delete the comment.

### **Would you like to obtain the connection data of a Dialicious Member?**

Dialicious cannot respond directly to your request.

Dialicious will only respond on this point to requests made by judicial or administrative authorities in accordance with its legal obligations.

It is up to you to take the initiative in the actions to be taken to allow Dialicious to contact the authorities.
